**Eligibility:** Open to all junior club and sanctioned racers J6-Masters (ages 6 and up).

**Seeding:** By age classification. Youngest to oldest by class.

**Entry Deadline:** January 20, 2006. Entries must be received by noon this date.  
Entry fee must accompany the entry form.

**Late Entries:** **Entries submitted after the posted deadline will be subject to a \$10.00 late fee per race. Late fees must be paid at registration in order to participate.**

**Liability Releases:** The bottom half of the race entry form is the liability release. If you cannot print one, call MARA at 245-5353 to have one mailed or faxed. Registered MARA program participants are covered with their MARA registration.

**Race Headquarters:** Ski Ashland Lodge on the fourth floor.

**Registration:** Opens at 8:00 am each morning on the fourth floor of the Lodge. Follow the stairs to the top. Liability releases and late fees must be turned in before a bib is issued.

**Lift Passes:** 6 and under free, 7 to 12 years are \$19, 13 to 17 are \$23. Adults are \$30. Registered racers can purchase discounted racer tickets at the ticket counter on the first floor from 8 am to 9 am from Ski Ashland. (Checks, Cash or Bankcards)
